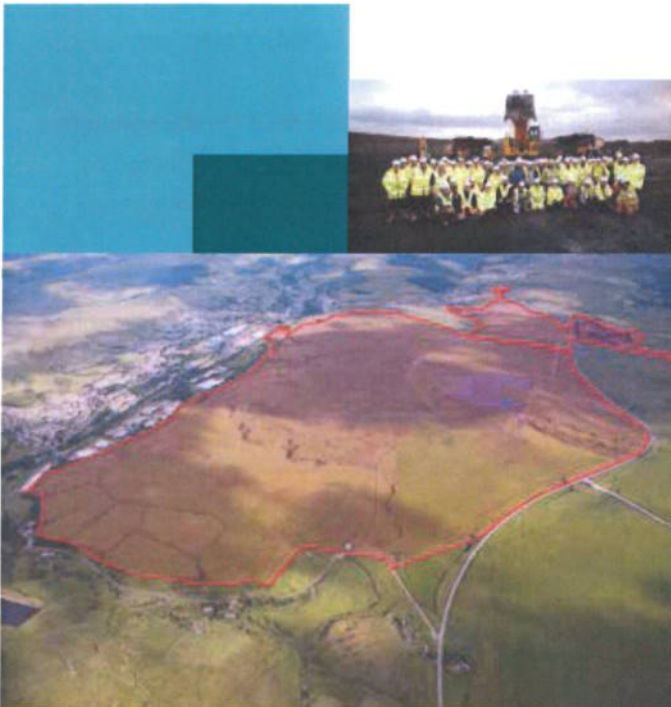

Errata

The following corrections are made to the planning application and supporting documents submitted for the Nant Llesg Surface Mine, Incorporating Land Remediation (Planning Reference: 13/0732/MIN):

1. **Planning Application Drawing MA/NL/PA/001**

The wording "Land in the ownership or control of the Applicant (Edged blue)" in the key should read "Adjoining land in the ownership or control of the Applicant (Shaded blue)".

2. **Planning Application Drawing MA/NL/PA/002**

The wording "Land owned or controlled by Miller Argent" in the key should read "Adjoining land in the ownership or control of the Applicant (Shaded blue)".

3. **Environmental Statement Volume 1 - Technical Assessments Part 1
Chapter 6 – Recreation and Tourism**

- a. The last sentence in paragraph 6.133 on page 35 in Chapter 6 should read "In the northern part of the Gelligaer and Merthyr Urban Common 297 hectares are currently affected by the FLRS, the Trecatti Landfill and that part of the CDP outside the Nant Llesg boundary; these are assessed as cumulative effects further below."
- b. References to "251 hectares" in paragraphs 6.183 on page 47 of Chapter 6 and paragraph 6.186 on page 48 of Chapter 6 should read "261 hectares".
- c. Reference to "452 hectares" in paragraph 6.187 on page 48 of Chapter 6 should read "462 hectares".
- d. The last sentence of paragraph 6.189 on page 48 of Chapter 6 should read "The combined effect on common land forming part of the Gelligaer and Merthyr Urban Common arising from Trecatti, FLRS, CDP and the Project is therefore 516 hectares or 16.69%."
- e. Reference to "487 hectares" in paragraph 6.190 on page 48 of Chapter 6 should read "516 hectares" and the words "...as a result of the Nant Llesg project, together with the FLRS and the Trecatti Landfill Site..." should read "...as a result of the Nant Llesg project, together with the FLRS, the CDP and the Trecatti Landfill Site...".

4. **Environmental Statement Volume 1 - Technical Assessments Part 1
Chapter 8 – Ecology and Nature Conservation**

- a. Paragraph number "12.1" on Page 48 of Chapter 8 is an error in the automated paragraph numbering of the chapter that affects all subsequent paragraph numbers. For reference purposes it is changed to "8.201A". Paragraph numbers following the new 8.201A remain unchanged.

- b. Paragraph numbers “12.2” and “12.3” on Page 53 of Chapter 8 are erroneous and affect all subsequent paragraph numbers. For reference purposes they are changed to “8.235A” and “8.235B” respectively. Paragraph numbers following the new 8.235B remain unchanged.
- c. Paragraph numbers “12.4” and “12.5” on Page 56 of Chapter 8 are erroneous and affect all subsequent paragraph numbers. For reference purposes they are changed to “8.248A” and “8.248B” respectively. Paragraph numbers following the new 8.248B remain unchanged.

5. **Environmental Statement Volume 1 - Technical Assessments Part 1**
Chapter 9 – Agricultural land use and Soils

- a. References to “197 hectares” or “197 ha” in Chapter 9 at paragraph 9.200 on page 38, paragraph 9.237 on page 43 and paragraph 9.239 on page 43, should read “261 hectares”.
- b. Reference to “nearly 400 hectares” in paragraph 9.240 on page 43 of Chapter 9 should read “462 hectares” and reference to “nearly 13%” in the same paragraph should read “nearly 15%”.
- c. References to “...the FLRS and Trecatti schemes” at paragraph 9.243 on page 44 of Chapter 9 and at paragraph 9.270 on page 48 of Chapter 9 should read “...Cwmbargoed Disposal Point and the FLRS and Trecatti schemes”.
- d. References to “The three schemes in total affect a maximum of approximately 435 ha of urban common...” at paragraph 9.244 on page 44 of Chapter 9 and at paragraph 9.271 on page 48 of Chapter 9 should read “The four schemes in total affect a maximum of approximately 516 ha of urban common...”.

6. **Environmental Statement Volume 1 - Technical Assessments Part 2**
Chapter 12 – Air Quality and Dust

Paragraph number “12.124” on Page 29 of Chapter 12 is duplicated. This error affects all subsequent paragraph numbers. For reference purposes, the numbering of the latter paragraph, commencing with the words “According to the Highways Agency...” is changed to “12.124A”. Paragraph numbers following the new 12.124A remain unchanged.

7. **Environmental Statement Volume 1 - Technical Assessments Part 2**
Chapter 13 – Noise

The wording of paragraph 13.45 on page 13 of Chapter 13 should read “Working hours for the surface mine will be restricted to 07.00 – 19.00 Mondays to Fridays and 07.00 to 14.00 on Saturdays”.
