#### THE COUNCIL'S EQUALITIES STATEMENT

- Pregnancy and Maternity
- Race
- Religion, Belief or Non-Belief
- Sex
- Sexual Orientation
- Welsh Language\*
- \* The Welsh language is not identified as a protected characteristic under the Equality Act 2010, however in Wales we also have to treat Welsh and English on an equal basis as well as promoting and facilitating the use of the Welsh language.

### PURPOSE OF THE PROPOSAL

#### 1 What is the proposal intended to achieve?

The proposal is to reduce the number of events that the Destination & Management delivers across our principal town centres.

The events programme consist of the following events:

- The Big Screen, Bargoed April & September
- Bargoed Spring Fayre
- Caerphilly Food Festival
- Blackwood Summer Festival
- Risca Summer Music in the park
- The Big Cheese
- Ystrad Mynach Christmas Market
- Bargoed Christmas Market
- Risca Parade and Christmas Market
- Blackwood Christmas Market
- Caerphilly Christmas Market
- Caerphilly Lantern Parade
- Bargoed Ice Rink (partially funded by Bargoed Town Council and Central Finance Fund)
- St David's Day events in Bargoed, Caerphilly, Ystrad Mynach, Blackwood and Risca

The lowest impact proposal will mean a removal of the funding and organisation of the following seven events:

- Risca Parade and Christmas Market
- The Big Screen April
- Bargoed Spring Fayre
- Caerphilly Lantern Parade
- Blackwood Summer Festival
- The Big Screen September
- St David's Day

Accompanied by associated reductions in the miscellaneous event budgets will contribute to an estimated £47,494 worth of savings.

#### 2 Who are the service users affected by the proposal?

User information is based on footfall data as recorded by the footfall cameras located in the town centres where recorded data is reliant on additional visitors coming in near proximity to the cameras located within each town centres (Bargoed Ice Rink is based on non-school ticket sales.

Visitor numbers tend to be highest at events based in Caerphilly.

The Bargoed Ice Rink attracted 46% of total admissions through school groups which in 2017/18 was an additional 1,021 to the table above.

#### IMPACT ON THE PUBLIC AND STAFF

An analysis of social media (Facebook) data shows that visitors expressing an intention to attend the events listed above are predominately female ranging from 76% for the Caerphilly Lantern Parade to 92% for the Risca Christmas Market.

The same data shows us that the age range for attending the various events is predominately of the age range 25 - 44.

The events offer family type attractions and are expected to attract a family audience.

The proposed reduction in the number of events from the current provision will retain at least one event per year in each of the principal town centres that an event is hosted.


