UK Parliamentary election For the ISLWYN constituency

10. An Election is to be held for a Member of Parliament to serve Caerphilly.
11. Nomination papers can be obtained from the office of the (Acting) Returning Officer, Gilfach House, William Street, Gilfach, Bargoed CF81 8ND on Monday to Friday between 10 a.m. to 4 p.m. (excluding bank holidays).
12. Nomination papers must be delivered to the (Acting) Returning Officer at Gilfach House, William Street, Gilfach, Bargoed CF81 8ND on any day after the date of this notice, on Monday to Friday 10 a.m. to 4 p.m. (excluding bank holidays) but no later than 4pm on Thursday 14th November, 2019.
13. If the election is contested the poll will take place on 12 December, 2019.
14. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Tuesday 26th November, 2019.
15. The £500 deposit can be paid by legal tender or by means of a banker's draft from a drawer, which carries on business as a banker in the United Kingdom.
16. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Gilfach House, William Street, Gilfach, Bargoed CF81 8ND by 5 p.m. on Tuesday Tuesday 26th November, 2019.
17. Applications to vote by proxy at this election must reach the Electoral Registration Officer Gilfach House, William Street, Gilfach, Bargoed CF81 8ND by 5 p.m. on Wednesday 4 December, 2019.
18. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Gilfach House, William Street, Gilfach, Bargoed CF81 8ND by 5 p.m. on 12 December, 2019. The physical incapacity must have occurred after 5pm on Wednesday 4 December, 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 4 December, 2019.
