

# Caerphilly's Budget Challenge

#### Caerphilly county borough is faced with having to make further savings in excess of £7.2 million in the next financial year (2018/19).

Last month, the council's Cabinet agreed a list of draft saving proposals and these are now subject to a period of widespread public consultation. Leader of the Council, Cllr Dave Poole said, "The council continues to work hard to minimise the impact of financial cuts on local residents. In fact, over half of the £7.2 million proposed savings for next year will not have a direct impact on the public."

"These savings will be achieved through, for example, vacancy management, structural reviews and procedural changes to service provision within the council. We will continue to do our best to prioritise our funding to protect vulnerable people and front line services, but our savings targets are very tough and we will need to take some difficult decisions over the next few years," he added. "The council is currently undertaking a far-reaching public consultation, and I would encourage as many residents as possible to get involved and have their say so that we can define our priorities and deliver a budget that matches the needs and aspirations of our communities."

> The budget consultation will run until **8th January 2018**. The feedback will then be considered as part of the final budget report which will be presented to the council in the New Year.

# Check before you eat this Christmas!

Many people will be planning their Christmas parties and evenings out with family and friends over the festive season, so the council's Food Safety team is keen to highlight the importance of checking the food hygiene rating of local eating establishments.

Certain food businesses are rated on their hygiene standards, based on inspections carried out by the Food Safety team. Businesses are rated from zero which means 'urgent improvement necessary' to a top rating of five which is 'very good'.

The team are currently working with businesses with a rating of two or less, by offering specific training on cleaning and disinfection, cross contamination, hand washing and temperature control, with the aim of helping them to improve their food hygiene practices and their rating.

Food Safety officers would also encourage anyone who is thinking of setting up a food business to get in touch for help and advice.

All Welsh businesses selling and providing food are legally required to display their rating sticker. If you are aware of a food business that is not displaying its food hygiene rating please report it by calling 01495 235340 or emailing foodhealthsafety@caerphilly.gov.uk

### Are you cooking this Christmas?

- There are some simple steps you can take when preparing your turkey which will help keep the festive period free from the misery of food poisoning.
- If you buy a frozen turkey, ensure it's **COMPLETELY THAWED** before you cook it by checking there are no ice crystals in the cavity. A larger turkey can take up to two days to defrost entirely.
- **DON'T WASH the turkey before cooking.** Washing is more likely to splash any bugs onto worktops, dishes and other foods. Proper cooking will kill any germs.

**Plan your cooking time properly.** Follow the cooking times and other instructions on the label. As a general rule, for a turkey under 4.5kg allow 45 minutes per kilo plus 20 minutes; for one weighing between 4.5kg and 6.5kg 40 minutes per kg plus 20 minutes; and for those over 6.5kg 35 minutes per kg plus 20 minutes – all at 180°C, 350°F, Gas Mark 4 (after the oven has preheated).

#### **Check the turkey is cooked properly** by cutting into the thickest part of the meat. None of the meat should still be pink, and any juices that run out should be clear.

Finally, the meat should be steaming hot all the way through.

## KNOW YOUR RIGHTS @ CHRISTMAS

Our Trading Standards team is keen to remind consumers about issues to look out for in the lead up to the festive season.

#### HERE ARE SOME TIPS TO CONSIDER:

- All goods purchased must be of satisfactory quality, fit for their purpose and as described. If you buy faulty or wrongly described goods the Consumer Rights Act is there to protect you. Act quickly, you may have 30 days to claim a refund, after this you may be offered a repair or replacement.
- Remember it is usually the purchaser of the goods not the person who receives them as a gift - who has the consumer rights. Some shops will give a gift receipt to allow the recipient of the gift to have the rights. Check before you buy.
- Ensure you check all purchases thoroughly to make sure they work before you wrap them. Keep all packaging until you are completely sure that everything is OK.
- Are you sure about your purchase? The law does not give you the automatic right to change your mind when you buy from a retail premises (eg If it's the wrong size or colour).
- Keep your receipts. Traders are entitled to ask for some kind of proof of purchase so it's a lot easier to prove that purchase with a receipt.
- When buying online your rights are enhanced. In most cases when you buy online you have a right to cancel your order and receive a full refund even if the goods are not faulty.
- Be careful about online purchases and only use reputable sites. Ensure you keep details of your order (Trader's name, address, contact details, order reference and product details). Make sure that any payments made are protected.
- You may wish to make purchases over £100 with a credit card (provided you clear your balance each month so that you do not incur interest charges). The credit card company is jointly liable for any problems and you will not have the same level of protection if you pay by a debit card.
- Try not to over-extend yourselves financially. Never borrow from expensive or illegal lenders as you could end up still paying for this Christmas, next Christmas.
- Watch out for fakes. Be suspicious of cheap designer goods, CDs DVDs or perfumes. These goods will be of a very poor quality and may be unsafe.

# Thanks for your GREEN efforts!

#### We would like to say a huge THANK YOU to everyone who has helped improve the quality of household recycling over the past few months.

The council was facing serious problems caused by a minority of residents placing inappropriate items in their recycling bin - such as food waste, pet poo and other non-recyclable materials.

This contamination was causing major issues for our waste contractors, as just one bin or black bag containing incorrect items could contaminate a whole lorry full of material. In order to address this issue the council undertook a major awareness-raising campaign to help remind householders about what can and cannot be recycled.

Cllr Nigel George, Cabinet Member for Neighbourhood Services said, "The positive response from residents has made a huge difference to the quality of our recycling and I would like to thank everyone for their efforts to date. Our waste contractor has reported a significant improvement in the quality of the recycling material being sent for processing, with a major reduction in the amount of contamination being found."

"It is important that we build on this success and encourage even more people to recycle fully in order to meet ambitious targets set by Welsh Government over the coming years."

The latest Welsh Government recycling figures show Caerphilly residents are the best recyclers in the Valleys with a 65.5% recycling rate. Over the past 20 years the Caerphilly average has increased by over 61 percentage points from 4.2% in 1998/99 when Welsh Government started to collect the data. This year's recycling rate of 65.5% is higher than the Wales average of 64%.

With Christmas fast approaching, the authority has agreed a number of positive measures to help keep Caerphilly moving and open for business during the festive period. At the time of writing, changes were being planned to alter the traffic management layout at the Pwll y Pant roundabout to help reduce congestion and improve traffic flow over Christmas and the New Year.

Fixed cameras are also being installed to transmit regular updated images of the latest traffic situation so that motorists can check online before setting out.

The council's Cabinet has also agreed to introduce 2 hours free parking in Caerphilly Town Centre pay and display car parks in December to help boost trade.

Cllr Sean Morgan, Deputy Leader of Council said, "We are aware of the significant impact that the roundabout works are having and we have listened to the feedback from motorists and local businesses."

"The council is always keen to support and promote the local High Street and we want to encourage as many people as possible to give the local economy a boost this Christmas. Our message is Caerphilly is still very much open for business."

The council and the main contractor, Walters UK Ltd, are continually monitoring the progress of the scheme and post-Christmas the traffic management arrangements will revert back to as they are now (single lanes) for a period of time.

Cllr Eluned Stenner, Cabinet Member for Public Protection said, "We want people to enjoy themselves and have a good time this festive season, but we also need to make everyone aware of the serious consequences that could arise from making bad decisions. People should think carefully about who's taking them home

tonight and the impact their behaviour could have on others this Christmas."

# **GET READY FOR WINTER**

Winter weather can be severe and can quickly disrupt our daily lives. By being aware and better prepared we can help minimise risk both at home, and when we are out and about. Even doing one or two simple things now could help save you time and money. Preparation now can also help you stay healthy and avoid becoming unwell. Below are some simple steps that can help you deal with severe weather:

**GET YOUR FLU JAB:** The annual flu vaccination is offered free to people who are most at risk. Contact your GP or pharmacist if you think you, or someone you care for, should be eligible for a free flu jab.

**IS YOUR VEHICLE READY FOR WINTER?** Check your vehicle is in good running order before you travel. Remember - before setting out always check the weather forecast.

**PREPARE A WINTER KIT:** You could get stuck in your car, so get a winter car kit ready (ice scraper, de-icer, jump leads, shovel, blanket, sunglasses for winter glare from the low sun, torch). For longer trips think about food, water and medicines too.

**CHECK YOUR PIPES ARE INSULATED:** Insulating pipes helps keep the heat in, saving you money, but it also means reduced risk of frozen pipes which can burst, causing flooding and leaving your home without water.

**KNOW WHERE YOUR STOP TAP IS:** Do you know where your stoptap (also called stopcock) is? It's something you should know so you can turn off the water to your home quickly should there be a problem.

**BEWARE STRONG WINDS:** In high winds trees or branches can come down, cast iron guttering could be lethal and so can roof slates. Garden furniture and even children's toys and trampolines can fly around causing damage and potential harm.

**PREPARE FOR A POWER CUT:** We are so reliant on the internet, but if a storm meant power and mobile phone networks were affected, what would you do? Consider a separate battery charger, and you could store key information such as the power cut helpline number (105) on your phone.

**FREEZE A FEAST:** Think about freezer-friendly foods and how to combine them with store cupboard staples so you can still serve up a feast for the family - even if you can't get out to the shops.

## IMPROVING AIR quality HOW CAN I HELP?

Air quality is currently high on the public health agenda, with research suggesting air pollution contributes to around 50,000 premature deaths in Britain every year. The bulk of the pollution is caused by vehicle emissions, but other sources include local industry, agriculture and bonfires.

The main pollutant is nitrogen dioxide, which is emitted from car exhausts. In accordance with the National Air Quality Strategy, the council's Environmental Health department actively monitors this pollutant around the county borough.

There are a number of steps drivers can take to help tackle air pollution, such as maintaining an economic driving style and turning car engines off when not in use. When engines idle, they are still using fuel and emitting pollutants. Turning car engines off when not in use and allowing sufficient time during winter months to properly defrost vehicles, uses less fuel and subsequently reduces atmospheric emissions.

It is worth noting that local authorities are able to issue fixed penalty notices to drivers who allow their vehicles to run unnecessarily whilst stationary. This includes stops longer than 1 minute (there are exceptions to the regulations). Burning domestic waste, plastics, wood, metal and garden waste etc in a bonfire emits various dangerous pollutants to the atmosphere. The council's waste and recycling service will collect the majority of household waste and is a cleaner alternative, which will enable the materials to be correctly disposed of or reused.

Under the Environmental Protection Act 1990, it is an offence to cause the emission of smoke that is prejudicial to health or a nuisance. The council currently has 22 Mini Recycling Sites and 6 Civic Amenity Sites that accept a wide range of waste material, which prevents the need for lighting a bonfire.

# Childcare Offer Extended

The new Welsh Government Childcare Offer is now available in additional pilot areas across the county borough and could bring huge financial savings for eligible parents working 16 hours or more per week.

From the term following their 3rd birthday, children could be entitled to 20 hours of government funded childcare. This is in addition to the 10 hours

already provided by the part-time Foundation Phase and up to 30 hours of childcare during the school holidays. Parents could receive the funding until they are offered a full time education place, usually the September after their child's fourth birthday potentially saving families in the region of up to £4,725 per year.





### Residents looking for a New Year challenge should look no further than the Caerphilly 10k, which returns for 2018 on Sunday 20th May.

Registration is now open for the popular annual event, which in 2017 saw over 2,450 runners of all abilities descend on Caerphilly from across the country to take part in the event. The 10k route will lead participants in and around the town centre, passing landmarks including the Tommy Cooper statue along the way and offering great views of the castle. Also returning is the Caerphilly 2k run, offering younger runners a chance to get involved in this timed event. Participants must be at least 8 on the day of the event in order to participate.

Entry fees are £20 for unaffiliated entrants, £18 for affiliated/Welsh Athletics entrants, £18 for concessions (over 60's and wheelchair users) and £6.50 for 2k runners.

# ENQUGH IS ENQUGH

#### THAT'S THE MESSAGE TO IRRESPONSIBLE DOG OWNERS ACROSS THE COUNTY BOROUGH AS THE COUNCIL LAUNCHES ITS NEW CAMPAIGN AIMED AT TACKLING ENVIRONMENTAL ISSUES, INCLUDING DOG FOULING.

In September this year, the council agreed to implement a series of new measures as part of a Public Spaces Protection Order (PSPO), which aim to tackle irresponsible dog ownership and dog fouling through enhancing the council's ability to enforce against irresponsible dog owners. Pupils from Ystrad Mynach Primary School joined the council to officially launch the 'ENOUGH IS ENOUGH' environmental awareness raising campaign at Ystrad Mynach Park. From Tuesday 14th November, any dog owner who is found to not comply with the following restrictions can be issued with a £100 fixed penalty notice. Pupils from Ysgol Gymraeg Cwm Gwyddon in Abercarn have also worked hard to produce impressive artwork as part of the 'ENOUGH IS ENOUGH' campaign, which has been transferred DIGON YW DIGON onto large banners in areas of high footfall to encourage dog owners to act responsibly.

#### THE RESTRICTIONS IMPOSED AS PART OF THE PUBLIC SPACES **PROTECTION ORDER ARE:**

- Excluding dogs from all enclosed children's play and multi-use games areas.
- Requiring dogs to be kept on leads in enclosed memorial gardens.
- Requiring dog owners to remove dog faeces in public places.
- Requiring dog owners to carry an appropriate receptacle for dealing with the waste that their dog produces (that is, to always have the means to pick up their dog faeces).
- Requiring dog owners to put their dogs on a lead when directed to do so by an authorised officer on any public land, where the dog is considered to be out of control or causing harm or distress to prevent a nuisance.

# **High Street Rate Relief**

Application forms have been sent to eligible ratepayers following the council's adoption of the Welsh Government's 'High Street Rate Relief Scheme' to provide support for eligible high street retail businesses in Wales affected by the recent rating revaluation.

The Scheme offers up to £500 discount on a business rate bill per property for Tier 1 properties and up to £1,500 per property for Tier 2 properties; the scheme only applies to the current financial year 2017-18. Cllr Colin Gordon, Cabinet Member for Corporate Services said, "We welcome the decision to support businesses, particularly those affected by the introduction of new levels of business rates from April 2017. I would encourage businesses receiving an application form through the post to complete and return it without delay."

## **Trading Standards warn against 'QUICK FIX' diet solutions**

Around one in three people in the UK are expected to make a New Year's resolution to lose weight and Caerphilly Trading Standards are



warning against 'quick fix solutions' that are often too good to be true.

The team are keen to remind anyone considering taking a food supplement that these are intended to supplement the diet and should not be regarded as a substitute for a varied diet and a healthy lifestyle. Before making decisions about lifestyle or diet changes, it is also important to talk to a qualified healthcare professional. Food supplements come in a variety of forms; traditional tablets, capsules, and powders, as well as drinks. There are many other types of foods marketed at those who seek to lose weight and sports nutrition is gaining in popularity. These products are strictly regulated in law to ensure they are safe and labelled correctly for consumers to make informed decisions.

Trading Standards are urging those who are considering purchasing food and food supplements sold on the high street, the internet and on social media, to source them only from reputable suppliers. At Cwmbran Magistrates Court in October 2017, Jeffrey Young, a Director of JY Nutrition

Limited in Pontymister, was sent to prison for 35 weeks, he pleaded guilty to 12 charges under various pieces of food legislation concerning the sale of food and food supplements.


