

SEASON TICKETS TERMS AND CONDITIONS

1. Season tickets may be purchased for use **only** in the following long stay car parks in Blackwood, Bargoed and Caerphilly –

2. Season tickets **are not** valid for use in the following short stay car parks.

3. Season tickets are only valid for **use in the car park stated** on the ticket.
4. The Council will not refund any monies in the event of either whole, or part of, one of the long stay car parks being closed or in the event of surrendering the season ticket before the expired date.
5. The Council will not guarantee a parking space being available.
6. In the Libanus car park only 20 spaces are available. Initially 6 will be reserved for resident ticket holders only. To ensure that the remaining spaces are fully used as practical, the Council may issue more tickets than the number of spaces. The number of tickets issued will be determined by experience.
7. For Gordon Road car park, residents of even numbers, 12-34a Gordon Road and 1-10 Albion Terrace, who are keepers of cars, may (in the first instance) apply for one season ticket per property. In the event that there are more spare spaces in the car park, consideration will be given to the issue of more than one ticket per property.
8. For Highland Terrace car park, residents of Graig View, Highland Terrace, number 6 Woodbine Road and odd numbers 7-11 Woodbine Road, who are keepers of cars, may (in the first instance) apply for one ticket per property. In the event that there are spare spaces in the car park, consideration will be given to the issue of more than one ticket per property.
9. Bedwas Road residents of numbers 21-23 Ton-Y-Felin Road are allowed to park in the loading zone area only and are able to purchase a permit at a reduced rate of £75. Non-residential permits are £350 per annum.
10. A replacement season ticket will be issued if:
 - i) The vehicle is an insurance write-off
 - ii) The vehicle has been stolen
 - iii) The vehicle has been changed (fee applicable)
11. Season tickets will be endorsed with the registration number of the vehicle to which it applies. For change of vehicle, the existing ticket (or written declaration that it has been lost, damaged, etc) must be returned prior to issue of a renewal.

12. Season tickets must be visibly displayed on the front windscreen.
13. Failure to comply with the car park regulation order will result in the issue of an excess charge notice. The Council also reserves the right to withdraw or cancel a season ticket, immediately and without refund.
14. The Council require a copy of the Vehicle Registration Certificate (V5C) with each application.
15. Please make sure that you send your renewal form at least one week in advance of your current Season Ticket expiring this is to ensure that your new ticket is received before your current Season Ticket expires.
15. In the event that the applicant may wish to surrender their permit, a credit note will be offered.
