**A4048, Pontllanfraith  
Temporary Prohibition of  
Driving Order 2021**

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along :-

A4048 from the roundabout at B4251 High Street and the roundabout at B4251 Penmaen.

The proposed Order is expected to commence on Monday 8th November 2021 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated that the works will be completed by 21st November 2021.

An alternative route will be available via B4251 Newbridge Road, B4251 Commercial Street, B4251 Blackwood Road, B4254.

Emergency vehicle access will be maintained. Pedestrian access will not be maintained.

The reason for making the Order is to allow for carriageway resurfacing works
