Disgwylir i'r Gorchymyn arfaethedig gau'r ffordd am sawl penwythnos. Disgwylir i'r Gorchymyn arfaethedig gychwyn ar 23 Awst 2021 am gyfnod nid yn fwy na deunaw mis neu nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf. Disgwylir i'r gwaith gael ei gwblhau erbyn 11 Hydref 2021.

Ni fydd mynediad ar gyfer gwasanaethau brys yn bosibl tra bydd y ffordd ar gau oherwydd cloddio'r ffordd i alluogi'r gwaith draenio. Bydd mynediad ar gael i gerddwyr lle bo hynny'n ymarferol. Bydd y llwybr gwyro i gerddwyr ar hyd Llwybr Beicio Cwm Darran a elwir hefyd yn Bristol Terrace.

Bydd llwybr arall ar gael ar hyd A469, Bailey Street, New Road.

**A469 Factory Road, Bargoed
Temporary Prohibition
of Driving Order 2021**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:-

Unnamed Road between Groes-faen Terrace and Factory Road.

The proposed Order is expected for multiple weekend closures. The proposed Order is expected to commence on 23rd August 2021 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated that the works will be completed by 11th October 2021.

No access for emergency services will be possible during the closures due to the road construction being excavated to enable the drainage construction. Pedestrian access will be maintained where practicable. The Pedestrian diversion route will be along the Darren Valley Cycle route also known as Bristol Terrace.

An alternative route will be available via A469, Bailey Street, New Road.

The reason for making the Order is to allow for drainage works.

The Order is required by Caerphilly County Borough Council.
