B4257 rhwng y cyffyrdd â Lady Tyler Terrace a Stryd Jerwsalem, Rhymni.

Disgwylir i'r Gorchymyn arfaethedig gychwyn ddydd Llun 18 Hydref 2021 am gyfnod nid yn fwy na deunaw mis neu hyd nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf. Disgwylir i'r gwaith gael ei gwblhau erbyn dydd Llun 1 Tachwedd 2021.

Bydd llwybr arall ar gael ar hyd yr A469 o'r draphont a'r B4257 trwy Lechryd a gogledd Rhymni; yn achos cerbydau nwyddau trwm sydd am gyrraedd Williams Medical Supplies, bydd angen mynd ar hyd Glan-yr-Afon a The Terrace o'r gogledd, neu, yn achos cerbydau sy'n llai na 4.3 metr o uchder, bydd modd mynd o dan draphont Pontlotyn.

Y rheswm dros wneud y Gorchymyn yw caniatáu gwaith cysylltu carthffosydd newydd.

Mae angen y Gorchymyn ar Encon Construction.

**B4257 Brynteg Crescent, Rhymney
Temporary Prohibition of Driving
Order 2021**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:-

B4257 from its junction with Lady Tyler Terrace and Jerusalem Street, Rhymney.

The proposed Order is expected to commence on Monday 18th October 2021 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated that the works will be completed by Monday 1st November 2021.

An alternative route will be available via A469 from the viaduct and the B4257 via Llechryd and Rhymney north HGVs wishing to access Williams Medical Supplies would need to utilize Glan-Yr-Afon and The Terrace from the north, or alternatively, vehicles below 4.3 metres in height can enter via Pontlottyn viaduct.

The reason for making the Order is to allow for new sewer connection.

The Order is required by Encon Construction.
