 - tu allan i rif 4 Parc Avenue, Caerffili
 - tu allan i rif 21 Whitethorne Street, Crymlyn
 - tu allan i rif 30 Hill Street, Trecelyn
 - tu allan i rif 34 Henry Street, Bargoed
 - tu allan i rif 69 School Street, Llanbradach

**(Prohibition and Restriction of
Waiting and Loading and On Street
Parking Places) Consolidation Order
2019 (Amendment Order No 9) 2021**

**Proposed Provision and Removal to
Disabled Persons Parking Places at
Various locations within Caerphilly
County Borough**

NOTICE is hereby given that Caerphilly County Borough Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004' Act) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act propose to make an Order the effect of which is to amend the Caerphilly County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019 by:

- a) restricting on-street parking for blue badge holders only, in a clearly marked out bay on the highway in the vicinity of the properties indicated below:
 - outside No 4 Lewis Street, Machen
 - outside No 35 Graig View, Ynys-ddu
- b) and to remove the existing parking order for blue badge holders only, in the vicinity of the properties indicated below:
 - outside No. 3A Llanarth Square, Risca
 - outside No's. 14-16 Bryn Heol, Bedwas
 - outside No 4 Parc Avenue, Caerphilly
 - outside No. 21 Whitethorne Street, Crumlin
 - outside No. 30 Hill Street, Newbridge
 - outside No. 34 Henry Street, Bargoed
 - outside No. 69 School Street, Llanbradach
