Temporary Prohibition
of Driving Order 2020**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to introduce a Temporary road closure on the following length of road:

Old Pant Road, Newbridge.

Alternative Route:

Old Pant Road, Central Avenue Crossways.

Duration:

The proposed Order is expected to commence on 30th March 2020. The proposed Order is for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier.

Emergency access will not be maintained.
Pedestrian access will be maintained.

Reason: To facilitate the installation of a draped mesh rockfall retention system.

Required By: Caerphilly County Borough Council.
