**Temporary Prohibition
of Driving Order 2020**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to introduce a Temporary road closure on the following lengths of roads:

Site Location 1 Pennar Lane Between its junctions with King Charles Road and Touchwood Bungalow

Site Location 2 Pennar Lane between its junctions with High Street and Touchwood Bungalow

Alternative Route:

Diversion 1. High Street, Unnamed Lane, Pennar Lane

Diversion 2 High Street, Coed Duon View, King Charles Road

Duration:

The proposed Order is expected to commence on Monday 9th March 2020. The proposed order is for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier.

Access for Pedestrians will be maintained. Access for emergency service vehicles will be not be maintained.

Reason: To carry out gas mains replacement works.
