**Temporary Prohibition of Pedestrians
Order 2020**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit pedestrians from proceeding along the following:

That section of Footpaths numbered Risca 176 and 178.

The proposed Order is expected to commence on 2nd March for a period not exceeding six months or until the works have been completed, whichever is the earlier.

Access for Emergency Services will not be maintained. There will be no pedestrian access.

No alternative route will be available.

The Order is required by Caerphilly County Borough Council.

The reason for making the Order is to allow for relining works to Monmouthshire and Brecon Canal.
