Temporary Prohibition of Pedestrians
Order 2020**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit pedestrians from proceeding along the following:

That section of Rudry Gwern Bridleways - Public Rights of Way - 11, 12, 17, 18, 26, 28, 35, 38, 39, 40, 41, 43. Footpaths - 14, 15, 16, 20, 27, 29, 30, 31, 32. Rudry Bridleway 36 & Footpath 38.

The proposed Order is expected to commence on 3rd February for a period not exceeding six months or until the works have been completed, whichever is the earlier.

No alternative route will be available.

The Order is required by Natural Resources Wales.

The reason for making the Order is to allow for tree harvesting operations.
