**Temporary Prohibition of
Pedestrians Order 2021**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

That section of Footpaths numbered 46 & 47, Llanbradach.

The alternative route for pedestrians will be available via the local highway network.

The temporary Order will be effective from Tuesday 9th November 2021 up to a maximum duration of six months or until the works are completed whichever, is the earlier.

The closure is required by Tilhill Forestry.

The reason for making the Order is to allow for timber harvesting.
