NOTICE is hereby given that
Caerphilly County Borough Council
in exercise of their powers under the
Road Traffic Regulation Act 1984 and
all other enabling powers and after
consulting with the Chief Officer of
Police have made an Order the effect of
which is: -

Allow One-way traffic on the Lane
from the junction of Gordon Road to
the North East Corner of the plot of
Land Adjacent to No, 3 Fairfield Close,
Blackwood.

The Order shall come into operation on
the 1st September 2021.

If you wish to question the validity of
the Order or of any of the provisions in
it on the grounds that it is not within the
powers conferred by the Road Traffic
Regulation Act 1984 on the grounds
that any requirement of that Act made
under it has not been complied with in
relation to the Order you may within six
weeks of the date hereof apply to the
Court for this purpose.
