HYSBYSIR drwy hyn fod Cyngor Bwrdeistref Sirol Caerffili, wrth weithredu ei holl bwerau o dan Ddeddf Rheoleiddio Traffig Ffyrdd 1984 ('y Ddeddf') a Rhan IV o Atodlen 9 i'r Ddeddf fel y'i diwygiwyd gan Ddeddf Parcio 1989, Deddf Rheoli Traffig 2004 ('Deddf 2004') a phob pŵer galluogi arall, ac ar ôl ymgynghori â Phrif Swyddog yr Heddlu yn unol â Rhan III o Atodlen 9 i'r Ddeddf, yn bwriadu gwneud Gorchymyn a fydd â'r effaith o ddiwygio Gorchymyn Cydgrynhoi (Mannau Parcio oddi ar y Stryd) Cyngor Bwrdeistref Sirol Caerffili 2019.

**Amendment to the Order to allow
enforcement of E-taxi bays
in Car Parks**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 ('the Act') and Part IV of Schedule 9 to the Act as amended by the Parking Act 1989, the Traffic Management Act 2004 ('the 2004 Act') and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, propose to make an Order the effect of which is to amend the Caerphilly County Borough Council (Off-Street Parking Places) Consolidation Order 2019.

The amendments to the legal order are required in order to formally restrict the use of appropriately marked bays to allow only E-taxi vehicles to park and electrically charge their vehicles in those designated spaces. The Order also will require that an E-taxi must be connected to a charger and shall not exceed the waiting time or regulated time indicated on the signage. The amendment to the Order will allow enforcement action to be taken should non-E-taxi vehicles park in the bays and if E-taxis are not utilising the charging points in the marked bays in accordance with the signage.
