Source and type of information being processed

Purpose and legal basis for using your information

Purpose of processing

To determine entitlement to payment by verifying details and confirming your identity, to facilitate any payments and to prevent, detect and investigate errors and fraud.

Legal basis for processing

There is a public task obligation to process your information detailed below:

We are processing your information to deliver the Energy Bills Support Scheme (EBSS) Alternative Funding service and Alternative Fuel Payment Scheme (AFPS) as set out by the UK government.

In order for the processing of personal data to be lawful under the General Data Protection Regulations 2016, a valid condition from Article 6 of the Regulations must be identified, which is outlined below:

1(e) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller;

Data Protection legislation provides extra protection for certain classes of information called 'special category personal data'. If any information falls within the definition of special category personal data then an additional condition from Article 9 of the Regulations must be identified, as outlined below:

2(g) processing is necessary for reasons of substantial public interest, on the basis of domestic law which shall be proportionate to the aim pursued, respect the essence of the right to data protection and provide for suitable and specific measures to safeguard the fundamental rights and the interests of the data subject;

Additionally as we are relying on the substantial pubic interest condition in Article 9(2)(g), a substantial public interest condition set out in Part 2 of Schedule 1 of the Data Protection Act (2018) must be identified, as outlined below:

6(1) This condition is met if the processing—

(a) is necessary for a purpose listed in sub-paragraph (2), and

(b) is necessary for reasons of substantial public interest.

(2) Those purposes are—

(a) the exercise of a function conferred on a person by an enactment or rule of law:

(b) the exercise of a function of the Crown, a Minister of the Crown or a government department.

Corporate Finance will be the main users of your information, they will check your details against the terms and conditions of the scheme and either validate the application, decline or contact you for further information. All decisions will be processed and notified via Salesforce.

If a payment is approved your data will be shared with the payments team in order to make a payment to you.

Personal information may be shared with other departments as necessary to deliver the Energy Bills Support Scheme (EBSS) Alternative Funding service and Alternative Fuel Payment Scheme (AFPS). For example we may determine eligibility using council tax or housing data.

Details of any sharing of your information with other organisations

We will share information back to the UK government Department for Energy Security and Net Zero (DESNZ) as part of our reporting obligations under the scheme. This information includes:

- Application reference number;
- Applicant's name (and any contact details for any third party individual supporting or making the application on behalf of the applicant);
- Date application received;
- Outcome of application and reason for decision-making;
- Assurance evidence in line with the Guidance (such as bank account details, Council Tax records, UK Driving licence, utility bill, care home invoice, tenancy agreement);
- Payment fraud or error, money recovered and subsequent fraud and error reporting

Requests for information

All recorded information held by Caerphilly County Borough Council may be subject to requests under the Freedom of Information Act 2000, Environmental Information Regulations 2004 and Data Protection legislation.

If the information you provide is subject to such a request, where possible Caerphilly County Borough Council will consult with you on its release. If you object to the release of your information we will withhold your information if the relevant legislation allows.

How long will we retain your information

Details of retention period

How long Caerphilly County Borough Council retains information is determined through statutory requirements or best practice.

Information supplied directly to CCBC (and not uploaded to Salesforce) will need to be kept for 7 years as it supports the payments made and grant payments to reimburse.
