## **1.0 SUMMARY**

- 1.1 This is the Caerphilly County Borough Council Joint Housing Land Availability (JHLAS) Study for 2011. It replaces the report for the previous base date of 2010.
- 1.2 This report presents the housing land supply for the area at the base date of 1st April 2011.
- 1.3 The JHLAS has been prepared in accordance with the requirements of *Planning Policy Wales* (Edition 4, February 2011), *Technical Advice Note 1 (TAN 1): Joint Housing Land Availability Studies* and the Guidance Note on the JHLAS process (June 2011). Please refer to these documents for details of the requirements for the maintenance of a five year housing land supply in each Local Planning Authority area and the process for undertaking JHLASs. - 1.4 Section 2 sets out details of the housing land supply and how it has been calculated. It shows that based on the residual method set out in TAN 1, Caerphilly County Borough has 4.3 years housing land supply.

### **Report production**

- 1.6 Caerphilly County Borough issued draft site schedules, site proformas and accompanying information for consultation between 07<sup>th</sup> July and 05<sup>th</sup> August 2011. A Statement of Common Ground (SoCG) was subsequently prepared by the Council and, following consultation with the Study Group, was submitted to the Welsh Government on 29<sup>th</sup> September 2011.
- 1.7 It was necessary for an appointed Planning Inspector to resolve a number of disputed matters in relation to four sites.

1.8 The appointed Planning Inspector subsequently prepared a report for the Welsh Government (see Appendix 4), making recommendations on the points of dispute. The Planning Inspector's recommendations were considered by the Welsh Government and this information has been incorporated into this report.

## 2.0 HOUSING LAND SUPPLY

2.1 The five year land supply comprises sites with planning permission (outline or full) and sites allocated for housing in adopted development plans, categorised as prescribed in TAN 1.

2.2 The land supply has been calculated using the residual methodology. The Local Development Plan for Caerphilly was adopted in November 2011 and will form the basis for this and future studies.

## 2.4 Small Site Supply

### 3.0 COMMENTARY

- 3.1 TAN 1 advises that to meet the requirement for a 5-year land supply the quantity of land agreed to be genuinely available may be compared with the remaining housing provision in the adopted development plan – the residual method.
- 3.2 The Council have recognised that under the residual method, the land supply is below five years. In such instances, paragraph 5.1 of TAN 1 states that the LPA “must include a statement in the JHLA study outlining the measures it is taking to address the shortfall in housing land supply.”
- 3.3 Policy SP14 of the Adopted LDP sets out a requirement of 8,625 dwellings to be developed over the plan period, but makes provision for 10,269 dwellings to allow for flexibility and choice. The Annual Monitoring Report (AMR) is the main mechanism for reviewing the relevance and success of the policies contained in the LDP and for identifying any changes that may be necessary. LDP Regulation 27 prescribes two indicators that must be included within the AMR, one of which specifically relates to housing land supply, taken from the current JHLA study. In line with para 4.1 of TAN 1 where the JHLA, and subsequently the AMR, identifies a shortfall in the housing land requirement, the Council will need to consider in consultation with the Welsh Government whether it would be appropriate or necessary to review the LDP in whole or in part. The first AMR that needs to be submitted to the WG in respect of the Caerphilly County Borough LDP will be for the period 01<sup>st</sup> April 2011 to 31<sup>st</sup> March 2012 and this will be submitted in October 2012.

### 4.0 MONITORING DATA

- 4.1 TAN 1 requires the JHLAS report to provide additional information on the development of land for housing covering the use of previously developed land, the use of sites subject to flood risk constraints and the type of housing being developed, i.e. houses, flats or other. This data is set out below.

- This report concerns the Caerphilly County Borough Council Joint Housing Land Availability Study(JHLAS) April 2011
  - The matters in dispute are set out in the JHLAS Statement of Common Ground (SoCG) Consultation Document dated September 2011
- 

### Recommendation

1. That the 2011 JHLAS housing land supply figure for the Caerphilly County Borough Council area be determined as 4.3 years.

### Context of the Recommendation

2. Planning Policy Wales (Edition 4 February 2011) states that Local Planning Authorities have a duty to ensure that sufficient land is genuinely available or will become available to provide a 5-year supply of land for housing. Technical Advice Note 1: Joint Housing Land Availability Studies (TAN 1) advises that the purpose of preparing a JHLAS is to:
  - Monitor the provision of market and affordable housing;
  - Provide an agreed statement of residential land availability for development planning and control purposes; and
  - Set out the need for action in situations where an insufficient supply is identified.
3. The scope of this report is to recommend an appropriate housing land supply figure in respect of the Caerphilly County Borough Council area, in the light of the matters in dispute concerning the calculation of such a figure and the available evidence.

### Main Issue

4. There is disagreement concerning the position of four sites included within the JHLAS schedule – Hawtin Park (Pontllanfraith), Hilary Rise (Pontywaun), The Quarry Moriah Hill (Risca), and Aberbargoed Plateau (Aberbargoed). This results in disagreement as to the number of housing units to be included within the land supply calculations.

## Reasons

5. It is common ground that it is appropriate to use the residual method of calculating land supply. This approach is in accordance with TAN 1. On this basis the Council considers the housing land supply equates to 4.3 years. However, if the disputed sites are excluded the supply reduces to 4.1 years.

### *Hawtin Park, Pontllanfraith*

6. Part of the site is allocated for housing in the Caerphilly County Borough Council Local Development Plan (LDP). In September 2010 the Council resolved to grant outline planning permission subject to a S106 agreement. The application includes the allocated housing land and adjoining land allocated for employment use. The JHLAS envisages 194 units being developed in total. The Council foresee 30 units being developed in each of the final 2 years of the 5 year period, whereas the Home Builders Federation (HBF) considers that the site should not be included as part of the 5 year supply until the S106 has been signed and there is a genuine intention to develop.
7. The S106 is being actively progressed and there is no evidence to indicate there is doubt with regard to the intention to develop the site. In these circumstances I find that the site is available and there is a reasonable prospect of the number of units being developed within the time-frame envisaged by the Council.

### *Hilary Rise, Pontywaun*

8. The site is allocated for housing in the LDP. The site has a long planning history and detailed planning permission was granted in September 2007 for 20 units. The Council indicates that since material work has been carried out, the planning permission has been implemented. Although the original developer is no longer operating, the Council considers that all the units could be developed within the 5 year period by another developer coming forward. The HBF indicates that, due to the uncertainty over the future of the site, it should be removed from the 5 year supply until there is evidence that a developer will come forward within the 5 year period.
9. Where sites have remained undeveloped for over 5 years there should be a presumption to reclassify such sites into Category 3i<sup>1</sup>. The site is being actively marketed and I consider there is reasonable prospect of the site being developed within the relevant time-frame. Furthermore, since the relevant permission is less than 5 years old, I do not consider this argument justifies the removal of the site from the 5 year supply.

### *The Quarry, Moriah Hill, Risca*

10. The site has a long planning history culminating in outline planning permission being granted for 14 dwellings in September 2009. The Council considers that all the units will be built in the final 2 years of the 5 year period. The HBF argues that since the 2009 planning permission was a renewal of a previous permission and the site has remained undeveloped for over 5 years, it should be removed from the 5 year supply since it does not consider there is a genuine intention to develop the land.
11. I am satisfied that it is appropriate to regard the 2009 planning permission as a new situation since it relates to a larger number of dwellings than the previous planning

permission. I note that in March 2011, permission was granted to undertake work to protected trees on the edge of the site. This work is necessary as part of the development of the site and I agree with the Council that it is a reasonable indication of the intention to progress the development of the site. On this basis I find there is reasonable prospect of the site being developed within the relevant time-frame. Furthermore, given the recent permissions that relates to the site I do not consider the retention of the site within the 5 year supply would be contrary to TAN 1 insofar as it relates to land that has remained undeveloped for more than 5 years.

*Aberbargoed Plateau, Aberbargoed*

12. The site is allocated for housing in the LDP, forms part of a wider Bargoed regeneration scheme and is owned by the Council. 413 units are to be developed and the Council envisages 30 units will be built in each of the final 2 years of the 5 year period. The HBF considers that the site should not be included as part of the 5 year supply since the site does not have developer interest, has not been marketed and has no planning permission. Furthermore, HBF consider there is potential for local objections to the site being developed. The physical constraints that have impeded development to date are being addressed and I agree with the Council that there is sufficient time for the necessary planning permission to be obtained and the site marketed to enable development to start within the anticipated time-scale.
13. Bearing in mind that the site is allocated for housing development in the LDP, I do not consider the possibility of local opposition is sufficient grounds to justify removing the site from the 5 year land supply.

**Conclusion**

14. For the reasons set out above, I conclude that the disputed sites should be included as part of the land supply for the 2011 JHLAS and the 2011 JHLAS housing land supply figure should be calculated as 4.3 years.
