A469 Pont Afon Rhymini, Bargod Gorchymyn Gwahardd Gyrru Dros Dro 2023

HYSBYSIR drwy hyn fod Cyngor Bwrdeistref Sirol Caerffili, wrth weithredu ei bwerau o dan Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (fel y'i diwygiwyd), yn bwriadu, mewn nid llai na saith diwrnod o ddyddiad yr Hysbysiad hwn, wneud Gorchymyn a fydd â'r effaith o wahardd cerbydau rhag mynd ar hyd:

A469 Pont Afon Rhymini, Bargod, rhwng Cylchfan Britannia a'r gyffordd â goleuadau traffig wrth fynedfa Ysgol Lewis Pengam am bellter o 950 metr.

Disgwylir i'r Gorchymyn arfaethedig gychwyn ar 22 Gorffennaf 2023 am gyfnod nid yn fwy na deunaw mis neu nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf. Disgwylir i'r gwaith gael ei gwblhau erbyn 3 Medi 2023 yn dibynnu ar y tywydd.

Ni fydd mynediad ar gael i'r gwasanaethau brys, cerddwyr na phreswylwyr.

Mae llwybrau amgen ar hyd A4049 Pengam Road, A472 Main Road, A469, A469 New Road, A469 Cardiff Road.

Y rheswm dros wneud y Gorchymyn yw caniatáu gwaith amnewid y waliau balast concrit cyfnerthedig.

Mae'r Gorchymyn yn ofynnol gan Gyngor Bwrdeistref Sirol Caerffili.

A469 Rhydney Riverbridge, Bargoed Temporary Prohibition of Driving Order 2023

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

A469 Rhydney Riverbridge, Bargoed between Britannia Roundabout and traffic signalised junction at the entrance to Lewis Boys School for a distance of 950 metres.

The proposed Order is expected to commence on 22nd July 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be completed by 3rd September 2023 depending on weather conditions.

Access for emergency services, pedestrians and residents will not be maintained.

Alternative routes are via A4049 Pengam Road, A472 Main Road, A469, A469 New Road, A469 Cardiff Road.

The reason for making the Order is to allow for replacement of reinforced concrete ballast walls.

The Order is required by Caerphilly County Borough Council.
