**Bridge Street, Blackwood
Temporary Prohibition of
Driving Order 2023**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Bridge Street between its junctions with Thorncombe Road and Davies Street for a distance of approx. 70 metres.

The proposed Order is expected to commence on 17th July 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be completed by 31 July 2023.

Access for emergency services and residents will not be maintained. Pedestrian access will be maintained.

The reason for making the Order is to allow for gas mains replacement.

The Order is required by Wales and West Utilities.
