Temporary Prohibition of Driving Order 2023

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along

Bridge Street from its junction with North Road and Newbridge Station car park for a distance of approx. 35 metres.

The proposed Order is expected to commence on 28th July 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier.

It is anticipated that the phases of the traffic Order will be in force for the following periods. Specific dates indicated are subject to changes.

PHASE 1 – 28/07/2023 – 31/07/2023 – 23:00 – 06:00 – 3 night shifts

PHASE 2 – 04/08/2023 – 07/08/2023 – 23:00 – 06:00 – 3 night shifts

Pedestrian and resident access will be maintained.

Alternative routes are via North Road, Main Street, B4251 Kendon Road, A467, Bridge Street.

The reason for making the Order is to allow for installation of ducting and lighting columns.
