TEMPORARY PROHIBITION OF DRIVING ORDER 2024

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Evans Road, Markham adjacent to numbers 21 - 24 for a distance of 40 metres.

The proposed Order is expected to commence on 22 July 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 25 October 2024.

Emergency services access will be maintained where possible. No resident or pedestrian access.

Alternative routes are via Bryn Road.

The reason for making the Order is to allow for drainage works.

The order is required by Caerphilly County Borough Council.
