Footpath 46 & 47 Llanbradach Temporary Prohibition of Pedestrians Order 2023

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

That section of Footpath Number 46 & 47 Llanbradach.

The alternative route for pedestrians will be available via alternative signed route.

The temporary order will be effective from 8th August 2023 up to a maximum duration of six months or until the works are completed, whichever is the earlier. It is anticipated that the works will be completed by 8th January 2024.

The closure is required by Tilhill Forestry.

The reason for making the Order is to allow for timber harvesting works.
