**Temporary Prohibition of
Pedestrians Order 2023**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

That section of Footpath Number
CRSK/FP130/1.

The alternative route for pedestrians will be available via adjacent public rights of way.

The temporary order will be effective from 14th November 2023 up to a maximum duration of six months or until the works are completed.

The closure is required by National Rail Infrastructure Limited.

The reason for making the Order is to allow for carrying out level crossing maintenance works.
