TEMPORARY PROHIBITION OF DRIVING ORDER 2024

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Mayhill Bungalows access lane, Blackwood.

The proposed Order is expected to commence on 11 March 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 5 August 2024.

Access for emergency services, residents and pedestrian access will be maintained where possible.

Alternative routes are via signed routes.

The reason for making the Order is to allow for drainage and carriageway improvements.
