## ALBERTINA ROAD, TREOWEN TEMPORARY PROHIBITION OF DRIVING ORDER 2024

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along

Albertina Road from its junction with Royal Crescent for a distance of approx. 58 metres.

The proposed Order is expected to commence on 2 September 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 15 September 2024.

Emergency services, resident and pedestrian access will be maintained where possible.

Alternative routes are via Florens Road, Parry Terrace.

The reason for making the Order is to allow for gas mains replacement.

The order is required by Wales and West Utilities.
