GELLI-UNIG PLACE PONTYWAUN TEMPORARY PROHIBITION OF DRIVING ORDER 2024

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along;

Gelli-Unig Place between its junctions with B4591 High Street and Trinity Hill for a distance of approx. 55 metres.

The proposed Order is expected to commence on 5 August 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 30 August 2024.

Emergency services, resident and pedestrian access will not be maintained.

Alternative routes are via North Road, Silver Street, Garden Suburbs.

The reason for making the Order is to allow for repairs to the road bridge.

The order is required by Caerphilly County Borough Council.
