Disgwylir i'r Gorchymyn arfaethedig gychwyn ar 24 Gorffennaf 2023 am gyfnod nid yn fwy na 18 mis neu nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf.

Rhagwelir y bydd camau'r Gorchymyn Traffig mewn grym am y cyfnodau canlynol. Gall y dyddiadau penodol a nodir newid.

**Cam 1** – 24 Gorffennaf 2023 i 30 Gorffennaf 2023

**Cam 2** – 30 Gorffennaf 2023 i 4 Awst 2023

## Llwyn on Crescent Temporary Prohibition of Driving Order 2023

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along

**Phase 1:** Road Closure:  
Llwyn on Crescent between Waungoch Road and Llwyn-on Road

**Phase 2:** Road Closure:  
Llwyn on Crescent between Waungoch Road and Garden House, Llwyn on Crescent

The proposed Order is expected to commence on 24 July 2023 for a period not exceeding 18 months or until the works have been completed, whichever is the earlier.

It is anticipated that the phases of the Traffic Order will be in force for the following periods. Specific dates indicated are subject to changes.

**Phase 1** – 24 July 2023 to 30 July 2023

**Phase 2** – 30 July 2023 to 4 August 2023

Emergency service, resident and pedestrian access will not be maintained.

Alternative routes are via Maesygarth Road, Oakdale.

The reason for making the Order to allow for resurfacing works and replacement of speed humps.

The Order is required by Amberon Ltd.
