ST CENYDD CLOSE TRECENYDD TEMPORARY PROHIBITION OF DRIVING ORDER 2023

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

St Cenydd Close, Trecenydd from its junction with St Cenydd Road for approximately 100 meters.

The proposed Order is expected to commence on 30 October 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be completed by 19 November 2023.

Access for emergency services, residents and pedestrians will be maintained where possible.

There are no alternative routes.

The reason for making the Order is to allow for replacement of kerbs and drainage works.

The order is required by Caerphilly County Borough Council.
