Temporary Prohibition of Pedestrians, Cyclists & Horses Order 2023

NOTICE is hereby given that Caerphilly
County Borough Council in exercise
of its powers under the Road Traffic
Regulation Act 1984 (as amended)
intends in not less than seven days from
the date of this Notice to make an Order
the effect of which will be to prohibit
pedestrians, cyclists or horses from
proceeding along:

That sections of CRSK/FP95/1,
CRSK/FP96/1, CRSK/FP97/1,
ABEC/FP96/1, ABEC/CROW216/1,
CRSK/CROW216/2, RISC/FP130, 140,
142, 143, 144, 145, CRSK/FP127, 124 in
the Community of Risca.

The alternative route for pedestrians,
cyclists and horses will be via any
suitable, alternative access.

The temporary Order will be effective
from 17th August 2023 up to a
maximum duration of six months or
until the works are completed.

The closure is required by Tilhill Forestry.

The reason for making the Order is to
carry out timber harvesting operations.
