**Temporary Prohibition of
Waiting and Loading Order 2023**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles to wait or load at any time along:

Park Lane, Caerphilly on the northern side from a point opposite the boundary of 13-15 St Fagans Street to the rear of the Peacocks store for a distance of approximately 16 metres.

The proposed Order is expected to commence on 3rd June 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be completed by 31 October 2023.

The reason for making the Order is to allow for construction works on Park Lane.

The Order is required by Lancer Scott Limited.
