TEMPORARY PROHIBITION OF PEDESTRIANS ORDER 2024

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

That section of Footpath Numbers RISC/FP 136/1, 137/1, 138/1, 138/2, 139/1, 140/1, 142/1, 143/1, 144/1 & 145/1. CRSK/FP 124/1, 127/1 & 128/1

The alternative route for pedestrians will be available via any suitable, alternative public access.

The temporary order will be effective from 12 September 2024 up to a maximum duration of six months or until the works are completed. It is anticipated that the works will be completed by 12 January 2025.

Access for emergency services will be maintained.

The closure is required by Tilhill Forestry.

The reason for making the Order is to allow for the carrying out of timber harvesting operations.
