## A469, Caerphilly Temporary Prohibition of Driving Order 2021

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along

A469, Caerphilly at its junctions from Pwll-y-Pant Roundabout to Trecenydd Roundabout.

The proposed Order is expected to commence for two individual overnight closures on 9th August for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated that the works will be completed by 1st October 2021.

Emergency service vehicles and resident access and pedestrian will not be maintained.

An alternative route will be available via Court Road, Brynhyfryd Road, Ael Y Bryn.

The reason for making the Order is to allow for removal and installation of refurbished footbridge.

The order is required by Caerphilly County Borough Council.
